- 3. Minutes from 2023 AGM: These had previously been circulated. There was one mistake in point 8 'Elaine Young became a Trustee at the Committee Meeting not the AGM' otherwise minutes acceptance proposed by Sara Fullerton and seconded by Adam Bassett.
- 4. Chairman's Report for 2023: Bryn gave this report to the meeting

2023 was the final push on renovation.

He thanked the committee for making the year a success.

Finance

This was a simpler year with less focus on grants.

Development

The 'Warm Room' has had a complete makeover and has now become a permanent fixture. Funding has been secured to allow it to continue

Bookings

There has been a big increase in bookings up 40% on 2022 and up 100% on pre Covid year 2019.

Improvements

This year has seen more improvements to the hall:

- a) The Meeting Room has had new chairs, carpets, walls painted and some great local photographs on the walls. Mostly funded by the Bank of Scotland Foundation.
- b) Main Entrance too has been painted and new carpets fitted partly funded by the BoS Foundation as well as hall reserves.
- c) New Fire Doors have been fitted to the main hall, stage and changing rooms. Funded by the Tea & Chat fund.
- d) A defibrillator has been fitted to the outside wall funded by the Robert Connal Trust.

5. Treasurer's Report:

Accounts for the financial year 2023

These accounts have been completed and audited.

Summary.

- Income:
 - Lets and fundraising was up to around £18,600
 - Grants income totalled £27,800
 - OVERALL: income was £46,400
- Payments/Outgoings:
 - With more use, cleaning costs have gone up as have electricity prices
 - Running costs were £21,800
 - Project Costs were £28,800
 - OVERALL: costs came to £50,600
- OVERALL:
 - Overall Deficit £4,200 mainly due to decoration not covered by grants,

The Hall can now take online payments by credit/debit cards through STRIPE.

Our annual grant was cut from £1000 to £750 in 2023 and maybe cut further

As a charity we receive a mandatory 80% exemption on rates and Stirling Council waive the other 20%. However with so many cutbacks at SC there is a worry about the 20%

.

6. Proposed pricing for 2024 - 2025

The price rises proposed recognise ongoing rises in costs.

These rises are kept minimal for community users.

- Costs and Income are being well managed by Peter.
