Finances

- More controllable year than last year with less focus on grants and associated complexities
- Bookings increased by 30% and rentals revenue is also up

Bookings

- Increased utilisation (up another 30% on 2023)
- We now average 34 hours of hall activities each week
- 57% of rentals are at concession rate
- All ticketed & commercial events pay full price

5. Treasurer's Report:

Accounts for the financial year to 31 Dec 2024

These accounts have been completed and audited.

Summary.

- Income:
 - Lets and fundraising was up to around £19,940
 - Grants income totalled £3,490
 - OVERALL: income was £23,430
- Payments/Outgoings:
 - Main costs are electricity £5215 and cleaning £2800. It is hoped to move to EDF in Nov and utilise feed in tariffs.
 - Total Running costs were £14,133
 - Project Costs were £10,408
 - OVERALL: costs came to £24,541
- OVERALL:
 - Overall Deficit £1,111 but a final electricity bill is expected.
- Bank Accounts:
 - We have both a current and deposit account with a combined Bank
 Balance at the end of 2024 of £26,168

6. Proposed pricing for 2024 – 2025

- Price rises required to recognise the ongoing rise in costs
 - Utility costs being managed but other costs continue to rise with insurance, cleaning etc all increasing.
 - Committee continue to look at cost control measures and opportunities to drive extra income for the hall.
 - Price rises minimal for community users (+5%)
 - but only from Jan 1st 2026 to give groups time to budget
